



# HobbyCon Events Mahjong + Yoga Retreat Participant Liability Waiver & Release Agreement

This Liability Waiver and Release Agreement (“Agreement”) is entered into between the participant identified below (“Participant”) and Hobby Nation LLC (“HobbyCon”) acting as Retreat Organizers (“Organizers”).

**1. ASSUMPTION OF RISK** I acknowledge that participation in the Retreat involves inherent risks, including but not limited to:

- Physical exertion during yoga sessions.
- Use of mahjong equipment, tiles, racks, and automatic tables.
- Participation in water sports and waterfront activities.
- Use of docks, decks, and uneven outdoor surfaces.
- Consumption of alcoholic beverages or other substances.
- Travel in shuttles, vans, or party buses.
- Group social and instructional activities.

I voluntarily assume all risks of injury, illness, property damage, or harm.

**2. HEALTH & FITNESS DECLARATION** I certify that I am physically able to participate in Retreat activities and will:

- Monitor my personal limits.
- Notify organizers of health conditions or allergies.
- Decline participation in activities that feel unsafe.

I voluntarily assume all liability and expenses for any necessary medical assistance. I allow organizers to seek emergency medical assistance at my own expense in case of a medical emergency.

**3. SUBSTANCE USE** If consuming alcohol, I agree to drink responsibly. I will not participate in yoga or water sports while intoxicated.

**4. WATERFRONT & WATER SPORTS** Participation in water sports is optional. I assume all related risks and will follow safety guidelines.

**5. TRANSPORTATION RELEASE** I release Organizers from liability arising from retreat transportation, including vans or party buses.

**6. PROPERTY RESPONSIBILITY** Organizers are not responsible for lost, stolen, or damaged belongings. I am financially responsible for any damage I cause to the premises, including accidental or negligent damage. If the responsible individual cannot be identified, costs may be divided among occupants of the affected room or area.

**7. COMMUNICABLE DISEASE & ILLNESS** I assume the risks associated with group environments and agree not to attend if I am contagious.

**8. RELEASE OF LIABILITY** I release HobbyCon, its organizers, volunteers, instructors, and partners from all claims arising from participation, including negligence.

**9. INDEMNIFICATION** I agree to indemnify Organizers from claims by third parties caused by my conduct.

**10. PHOTOGRAPHY & MEDIA CONSENT** I authorize use of photos or videos including my likeness for promotional purposes unless I opt out.

**11. ACKNOWLEDGMENT** I certify I have read and understand this Agreement and sign voluntarily.

## Participant Code of Conduct

**Event Dates:** Friday, May 22nd - Monday, May 25th 2026

**Location:** Long Island, NY (North Shore Waterfront Houses)

### 1. Rooming & Sleeping Arrangements

- No sharing beds with strangers.
- Only participants who choose to room together will share a bed/room.
- No entering rooms not assigned to you.

**2. Quiet Hours** Quiet hours are 11:00 PM – 7:00 AM daily.

### 3. No Smoking, Vaping, or Pets

- Smoking and vaping are strictly prohibited inside the houses, on porches, decks, patios, and within 25 feet of any entrance.
- Pets of any kind are not permitted on the premises during the retreat, including emotional support animals (service animals are exempt as required by law and must be disclosed prior to arrival).

### 4. Alcohol Guidelines

- Drink responsibly.
- No participation in yoga or water sports while intoxicated.

### 5. Respect for Shared Spaces

- Clean up after yourself.
- Respect kitchen, bathrooms, and common areas.

### 6. Behavior Expectations

- No harassment, discrimination, violence, or aggressive behavior.
- Be inclusive and considerate.
- Notify organizers immediately if issues arise.

### 7. Activity Participation

- Participation is optional.
- Instructions must be followed during yoga and mahjong sessions.

**8. Personal Property** Organizers are not responsible for lost, stolen, or damaged items.

### 9. Property Damage & Responsibility

- I understand that the retreat houses are private residences provided for participant use.
- I agree to treat all property, furniture, appliances, décor, and outdoor areas with respect.
- I will immediately notify Organizers if any damage occurs.

### 10. Safety

- Follow all retreat guidelines.
- Do not engage in excursions or activities outside the premises alone.
- Notify organizers if feeling unwell or any other issues arise.

I understand and agree violation of this policy may result in removal from the retreat without refund, and participants may be responsible for any additional cleaning fees, odor remediation, or damage charges imposed by the property owners.
